The Berea Lawn Tennis Club (BLTC) is one of the oldest tennis clubs in South Africa with a history of over 100 years. As at 1 April 2019, the BLTC merged with another established tennis club, Tills Tennis Club which had an illustrious history in the Sydenham, Mayville and Overport areas.

The revamped Berea Lawn Tennis Club is fully registered with the city, regional and national tennis regulatory bodies and participates actively as a social club, development hub, as well as a venue for social and tennis related activities. It is one of the few tennis clubs which has floodlights on 2 of its courts.

Tennis Activities (League)

The BLTC is fully participative in the league schedules and has registered teams in the Over 40's, Mixed Doubles, Ladies Doubles and Mens Doubles.
